### **Monday, June 24, 2024:**

### **Review of March 19, 2024, Meeting Minutes**

### **MT Grain Growers**

He talked about their upcoming meetings and convention. Boyd let the board know about the new hire for the Director of Policy position, Kera Birkeland. She will be working with John Semple, to learn the ropes.

### **US Wheat Associates**

Vince Peterson the president of US Wheat Associates came and talked about the world grain situation and how it affects the producers of Montana.

### **Department of Agriculture Update**

Director Clark gave the update for the department, summer is always slow, most employees are out in the field working. She attended many events and spoke at a lot of them. One of them was with the EPA to answer questions the department and others had concerning the Invasive Species Act. She brought everyone up to speed on bills and budgets that will be going before the Legislature this fall. The director talked about the changes at the State Grain Lab, including the new executive, Tristan Bradford.

### **Grain Trade**

Jake McFarlin gave a weather update first; in his area he saw hail and thunderstorms that affected what was a great winter wheat crop. In the meantime, grain prices have been going from one extreme to the next. The US has become more competitive to the Russia grain market. He talked about the railroad and some of their issues.

- Director Bradley – Got a good snow so crops doing good. USWA World Staff Meeting – Good trip and gave a presentation.

### **National Agricultural Statistics Service**

Eric Summers talked about budget cuts at NASS and how it will affect MWBC programs. Redoing some of the sampling for both winter wheat and barley to make more sense.

Kolleen Spurgin presented the financial update including refunders.

### **Communication Director Report**
